## **Treasure Hunt.**

In September the Reading Learning Disability Partnership held a treasure hunt which aimed to encourage people to use public transport. The venue was kept a secret until the day of the treasure hunt.

People who had registered to take part were given the Partnerships symbol which they had to take to the Reading Buses Travel Centre in Broad Street Mall and show they had travelled into Reading by bus or Readibus to get the clue to where it was being held. People were asked if they had a bus pass when they registered and were sent an application form if they said no.

The treasure hunt took place in the Forbury Gardens. People took part in teams and had to follow the photo clues to complete the hunt. Those who were the fastest won prizes which included tickets for a football match, the pantomime at the Hexagon, a river cruise and ten pin bowling.

Lots of different people took part including students from The Bridge at Prospect School who really enjoyed travelling on the bus into Reading. Everyone enjoyed themselves and said they would like to do a treasure

hunt every year.

At the March meeting we will be celebrating what the Partnership has been doing over the past year and we will make sure this helps us with the report the government has asked us to complete.

We all agreed that next year it would be a good idea if each of the work groups plans the open events.

### **Report.**

The government wants all Learning Disability Partnerships to send a report every year telling them what they are doing.



They have published a guide telling us how Partnership Boards should be working and who should be members. It also gives us the report so that we can

see what we need to do to fill it in. Debra will send this out to all members of the Partnership.



### **Membership of the Partnership and work groups.**

Debra has contacted several of the members who have not attended the recent meetings and only got one reply. We agreed that a more formal letter from the co-chairs will be sent followed by a phone call if there is no reply.

The new Partnership Board guidance tells us who should be members of the board so we will use this list when we are inviting new members to join us.

We will also update our terms of reference so people know what the Partnership does and what is expected of them as members. We will also say that if you do not attend three meetings in a row then we will assume that you no longer wish to be part of the Partnership and will look for another representative from your organisation or a similar one.

We now have more people attending the work group meetings and have good input from a lot of different people.

All of the service user representatives have agreed what work they will be doing for their group and are keen to start that work.



### **Transition.**

Jo Poynter from the Valuing People Support Team wants to come to one of our Partnership meetings to talk about the new transition toolkit which has been developed by Surrey. Jo will buy a copy for each Partnership but she would like to come along and find out what we are doing for young people in transition. We agreed that we will invite Jo to the meeting in March.

Staff from children and adult social services as well as staff from schools, health and other organisations have

been invited to a meeting to complete the transition assessment sent to us by the government. This will be completed by the 1<sup>st</sup> December.



### **Valuing Employment Now.**

The South East Region will be holding a conference to tell us about Valuing Employment Now in London this week. Debra will attend and let the Partnership know what was said at the conference.

Keith asked if we could find out what is going to be done to make it quicker to get a person back onto benefits if they can no longer work.

The Learning and Working group will be looking at Valuing Employment Now at it's next meeting and will make sure that what we need to do to make this happen for people in Reading is in our action plan.
